EXPORT REQUIREMENT AND PROCEDURE FOR EXPORT EGG AND EGG PRODUCTS TO JAPAN

Animal Health Requirements for egg product Exported to Japan:

- 1) *Malaysia has been free from Notifiable Avian Influenza for at least 90 days prior export.*
- 2) *Newcastle disease has not occurred for at least 90 days prior to export, within a minimum radius of 50 km from the production farm and the processing plant where the shell eggs were/was produced, collected, selected, disinfected, processed and packed.*
- 3) *The eggs for export were sourced from Department of Veterinary services, Malaysia (DVS) approved farm which have been free from fowl cholera and other poultry diseases for at least 90 days prior to export of the shell eggs or liquid egg.*
- 4) *The exported eggs were collected, selected, cleaned, disinfected and packed under hygienic conditions in Department of Veterinary Services, Malaysia (DVS) approved processing plant.*
- 5) *The shell eggs were/was transported from the production farm to the processing plant under hygienic condition.*
- 6) *The shell eggs/liquid egg were/was packed in new and clean packing material.*
- 7) *The shell eggs/liquid egg are/is stored or packed using new and clean packages or containers, and handled in a way to prevent exposure to any pathogenic pathogens prior to export.*

Procedure to Export Egg or Egg Product from Malaysia to Japan

1. *The application for approval to export of egg and egg product must made by writing directly to:*

2. *In the application letter, please attach information as below:*

- i. *Company profile*
- ii. *List of item/product to be exports*
- iii. *Ingredient detail of the item/product – if a value added product*
- iv. *Process Flow chart of the item/product – if a value added product*
- v. *Contact person and contact number*
- vi. *Certification of MYGap or VHM*
**The farm or manufacturing shall have MyGap or VHM from Department of Veterinary Services*
- vii. *Certificate of analysis*

3. *Approval to export will be given based on audit documents and on-site inspection.*
4. *Approval letter will be issued when the exporter/company has fulfilled the requirement from Japan.*
5. *Before shipment, exporter is responsible to apply the VHC and export permit through the online e-Permit system.*
6. *The consignment to Japan shall be SEAL with DVS SEAL.*
7. *The seal number shall declare in the application VHC through system.*
8. *Wait for the application status in the e-Permit 1 system to be "Acknowledge by Custom".*
9. *After 3 days from the status "Acknowledge by Custom", exporter can come and collect the VHC from Import Export Counter DVS State and the export permit from MAQIS (can be print by the exporter as no official signature required).*
**It is advisable to apply the export permit and VHC online at least 1 week prior to the export date as the permit is valid for 30 days.*
